Privacy Policy (Psychotherapy Internship)

1. Personal Data Controller

The personal data controller for internship participants is Institut für Psychotherapie, represented by Marta Leuenberger.

2. Purpose of Data Processing

Personal data of participants is processed for the purpose of:

- 1. Implementation of the internship program, including organization of workshops, supervision, and therapeutic sessions.
- 2. Contacting participants regarding organizational matters and providing educational materials.
- 3. Issuing completion certificates for the internship.
- 4. Compliance with obligations arising from legal provisions.

3. Scope of Collected Data

The following personal data is processed:

- Name and surname

4. Legal Basis for Processing

The legal basis for processing personal data is:

- 1. Consent of the participant expressed during registration for the internship.
- 2. Necessity of data processing for contract fulfillment (internship organization).
- 3. Fulfillment of legal obligations incumbent upon the controller.

5. Data Sharing

Personal data of participants may be shared with:

- 1. Supervisors and therapists conducting classes for the purpose of implementing the internship program.
- 2. Entities servicing online platforms, such as Zoom or Google Meet.

Data will not be transferred to third countries outside the European Economic Area, except in situations arising from the use of services provided by online meeting platform providers.

6. Data Retention Period

Personal data will be retained for the period:

- 1. Necessary for implementing the internship program and issuing certificates.
- 2. 5 years from the completion of the internship for archival purposes, in accordance with applicable regulations.

7. Participants' Rights

Participants have the right to:

- 1. Access their personal data and receive a copy thereof.
- 2. Rectify incorrect data.
- 3. Delete data ("right to be forgotten") in case of absence of legal basis for their processing.
- 4. Restrict data processing.
- 5. Transfer data to another controller.
- 6. Object to data processing.
- 7. File a complaint with the supervisory authority for personal data protection.

8. Data Security

The controller undertakes to implement appropriate technical and organizational measures to protect personal data against unauthorized access, loss, or unauthorized processing.

9. Changes to the Privacy Policy

The controller reserves the right to introduce changes to this policy. Participants will be notified of all changes electronically.

Psychotherapy Internship Regulations

1. Internship Objectives

The objective of the internship is to enable gaining practical experience in cognitivebehavioral psychotherapy, develop therapeutic skills, and provide support in building selfconfidence in working with patients.

2. Participation Requirements

- 1. Status of a final-year student or graduate in psychology or related fields.
- 2. Interest in cognitive-behavioral therapy and motivation for learning and development.

3. Internship Program

- 1. Live consultations and sessions with patients: Observation and conducting therapeutic sessions under supervision.
- 2. **Practical workshops/webinars**: Theoretical classes and therapeutic session simulations.
- 3. **Supervision**: Sessions with experienced therapists for case analysis.
- 4. **Access to educational materials**: Ready-to-print therapeutic tools and professional literature.

4. Schedule and Format

- **Duration**: 3 months
- Format: Online classes and remote patient consultations
- Detailed schedule of workshops and supervision will be provided to participants

5. Participant Obligations

- 1. Participation in workshops, supervision, and patient consultations.
- 2. Completion of a minimum of 10 therapeutic sessions.
- 3. Active engagement and adherence to professional ethics principles.

6. Fees and Refunds

- The internship is paid. Installment payments are possible.
- Withdrawal is possible no later than 30 days before the internship begins, with the possibility of partial fee refund.

7. Certification

Upon completion of the internship, participants receive a certificate confirming the number of hours and acquired skills.

8. Final Provisions

- 1. The organizer reserves the right to make changes to the schedule for important reasons.
- 2. Participants are obligated to observe confidentiality rules and patient data protection.

Personal Data Protection Policy

1. Purposes of Personal Data Processing

3. Recipients of Personal Data

Data may be shared with the following entities:

- communication platform providers (Zoom, Google Meets),
- companies servicing accounting and legal systems,
- entities supporting marketing activities, such as advertising agencies or mailing service providers.

4. Data Retention Period

Personal data will be retained for the period of:

- the duration of the internship,
- 5 years after the completion of the internship for archival purposes, in accordance with legal provisions,
- until consent is withdrawn in the case of data processing for marketing purposes.

5. Your Rights

You have the right to:

- access your data,
- rectify data,
- delete data ("right to be forgotten"),
- restrict processing,
- data portability,
- object to data processing for marketing purposes,
- withdraw consent to data processing at any time.

6. Complaint to Supervisory Authority

In case of violation of personal data protection regulations, you may file a complaint with the Bundesbeauftragter für den Datenschutz und die Informationsfreiheit (BfDI) in Germany.

7. Voluntary Nature of Providing Data

Providing personal data is voluntary, however, its absence may prevent:

- issuing completion certificates,
- sending information about new educational offers.

8. Processing Data for Marketing Purposes

If you consent to it, your data may be used for sending marketing materials, including:

- information about new courses, training, and webinars,
- special offers and promotions,
- invitations to industry events.

Consent for marketing activities may be withdrawn at any time without affecting the lawfulness of previous processing.

9. Automated Decision-Making

Personal data will not be used for automated decision-making, including profiling.

10. Data Protection Measures

11. Consent to Data Processing
